


Fiscal Year 2021 (January 1, 2021 to December 31, 2021)

Philanthropic Giving 2021 \$908,007





SPECIAL GIFTS AND GRANTS

Agnes Lindsay Trust

With a grant from the Agnes Lindsay Trust, Bethany Health Care Center was able to purchase new High-Low Therapy Mat Tables to provide a safer treatment surface for physical therapy patients and caregivers.

"The new treatment tables are well-suited for the needs of Bethany's outpatient clinic, and for both clinicians and our patients," noted Physical Therapist Danielle Westerman, "For the clinician, the table offers full-height adjustment and section mobility so patients can be placed in the proper position for maximum results with minimum effort. Equally as important, for our patients it provides easy access getting on and off the table, with customized positioning adjustments for maximum patient comfort during treatments."

Updated equipment is essential for Bethany's Rehabilitation Department to continue delivering quality healthcare while utilizing evidence-based and best practice approaches.



This new state-of-the-art equipment will offer a safe and healing environment and further improve the physical and emotional wellbeing of Bethany's residents.

Catholic Health Foundation

The Catholic Health Foundation awarded Bethany Health Care Center a generous grant that allowed us to purchase critically needed medical equipment. These resources assist residents with their recovery process and prevent negative outcomes during their return to good health.

According to Maureen Dulko, RN, Director of Nursing, "The Bethany staff was thrilled to receive the most current and high-quality treatment modalities available in this health care setting. Residents who underwent joint replacement procedures were able to maintain and improve their mobility. This allowed for their Physical Therapy sessions to be less painful and promoted a positive healing outcome in a shorter amount of time.

Nutritional crises were averted as a result of better monitoring equipment which allowed our Registered Dietician to confidently put nutritional interventions in place. The Enteral Feeding pump has assisted Nurses with time management and has allowed residents to enjoy a quiet peaceful environment without the need for nursing interruption in their lives. The Handheld Ultrasound machine has been used frequently by our clinicians and has directly affected intervention decisions. It has significantly reduced the need for outside diagnostics and trips to the ER."

Cummings Foundation

Bethany is delighted to have received a \$100,000.00 Cummings Foundation grant to help replace its major kitchen appliances, which are more than twenty years old and past their useful lifespan. The walk-in refrigerators and freezers are being replaced with new high-efficiency equipment. The updated appliances will increase safety while reducing energy usage and cost, in line with Bethany's commitment to caring for the Earth.

"Meals are one of the most essential elements of a nursing home resident's day. Proper nutrition contributes substantially to overall health, and a pleasurable dining experience is known to enhance happiness, satisfaction, and well-being. Enjoying a meal in others' company is an important part of the human experience and increases a sense of comfort and community," said Sister Jacquelyn McCarthy, CSJ, RN, CEO/ Administrator.

Charlotte E. Flatley Gift Fund and The Yawkey Foundation

Through generous grants from the Charlotte E. Flatley Gift Fund and the Yawkey Foundation, Bethany has purchased new furniture, including recliners, dressers, bedside nightstands, and wardrobes in resident rooms throughout the facility.

Jim Argir, Executive Director, shared, "Transitioning to a nursing home can be a difficult and emotional life event. Several factors affect a person's sense of 'home' in a long-term care environment. The comfort and personalization of one's bedroom are critical and profoundly impact the feeling of being 'at home' for elderly residents. Having well-functioning and aesthetically pleasing furniture forms the basis for a homelike atmosphere in the resident's bedroom. Bedside nightstands, desks, and dressers allow residents to display personal photos and mementos in addition to storing their favorite clothing and other personally meaningful items. Lockable drawers help

seniors maintain a sense of personal space and control over precious belongings that connect them with their life experiences and loved ones. Comfortable recliners provide a cozy place to relax and enjoy a favorite book or take a nap. We are tremendously grateful for the Flatley and Yawkey donations that made this furniture update possible."

A LEGACY OF LOVE - MARJORIE LOCKE NOONAN

Marjorie (Margie) Noonan had a deep love for, and connection with, the Sisters of St. Joseph of Boston. She grew up in Quincy as one of four sisters who all attended Fontbonne Academy. Margie entered the convent and became a member of the Congregation when she was eighteen years old, making lifelong friends among her fellow Sisters.

Over time, Margie yearned for the closeness and belonging that a family of her own could bring, which led her to leave the Congregation after eight years. However, Margie remained close with several Sisters, especially her mentor and friend, Sister Roberta Marie Brown, CSI.

Margie worked as an elementary school teacher in the Milton Public School District She loved teaching and found it very rewarding. Eventually, Margie met her best friend and love of her life, Peter Noonan. Margie and Peter were married, and she loved and helped raise Peter's five children as her own. Margie also successfully developed and owned gas stations in Falmouth, Dennis, and Nantucket.

A few months before her passing from a short illness, Margie shared with her dearest friend, "I am filled with gratitude for the goodness of God, for Peter and for his family who became my family, for my family who became Peter's family. It may seem strange to say but I am grateful even for this illness though it is so difficult to face with wisdom and grace, as the nuns would say. It is my challenge. It is what God wants me to do. I don't know the reason except for the fact that it is an opportunity to show the world how surrounded I am by love."

Margie remained devoted to her faith throughout her life and was an active philanthropist. When she learned that her illness was terminal, she was adamant in her desire to support the retired Sisters of St. Joseph in a meaningful way, in memory of her dear friend and mentor, Sister Roberta Marie.

Margie's Legacy Gift was the catalyst for Bethany to be able to undertake a criticallyneeded renovation of its Lobby and Assumption Room spaces. Bethany CEO/ Administrator, Sister Jacquelyn McCarthy, CSJ shared, "The next step in the transformation of
